#### CALL TO ORDER

GPTN President Greg Rosenboom called the meeting to order at 7:01 pm.

### **GUEST PRESENTATION**

The guests addressed the funding of the Rock Island to Jamaica North Connection Project (RIJN). Yost distributed a report indicating that the cost of the project is estimated as \$2,217,469, and funds in hand or pledged amount to \$2,012,700—a gap of \$204,769. There are grant proposals pending that total \$165,000. In order that construction begin this calendar year the city must have the full amount in hand or pledged by the end of the month. Breed circulated the draft of a letter to the Mayor from the presidents of NTF and GPTN and urged the board to instruct the president to sign the letter pledging that NTF and GPTN would raise an additional \$210,000 to close the gap. He indicated that NTF had already agreed to sign. Discussion ensued.

Stevens moved Briseno seconded that President Rosenboom sign the letter and that GPTN and NTF will use our best efforts to raise \$210,000. Unanimously approved.

Noé reported that a fundraising campaign "Giving Tuesday" will soon be announced to members which will offer match gifts (up to total of \$5k) with gifts from the GPTN board. So far \$3k has been pledged by board members.

On another issue, Hartzell reported that a consultant had been hired to address future plans for Wilderness Park, including how people enter and move through the park.

## APPROVAL OF MINUTES

Minutes of the October board meeting were approved.

### TREASURER'S REPORT

Treasurer opined that it was a "pretty quiet October", but we have "ways to go" to make membership revenue the same as last year. Report was distributed electronically before the meeting.
