## **GPTN Bylaws**

- Reviewed Amendments by Hirsch.
  - Amendment #1. Article II. Membership. "to all persons"
    - Wehrbein moved, Case seconded. Approved.
  - Amendment #2. Article II. Membership. "#6. Voting. Each membership, regardless of membership category, shall vote one vote."
    - Thacker moved, Heinrich seconded. Approved.
  - Amendment #3. Article II. Membership. "Cumulative voting" clarification.
    - Wehrbein moved, Case seconded. Not approved.

# **STANDING COMMITTEE REPORTS:**

## **Fundraising Committee**

- Bentrup gave report on N Street.
  - N Street three grants submitted (15k to Cooper, 2500 from Olson Associates, 2500 from Scott Family Foundation). Received 5k from Union Bank. 180k in NTF for N Street.
    50k coming at end of project from another donor. About 110k away from fulfilling GPTN commitment. Fundraising letter just went out to 600 Physicians regarding N Street.
  - $\circ$   $\;$  Griffin mentioned local Community Services Fund application for local and national.
  - Give to Lincoln Day is coming up.
  - Funds from Trail Trek in 2015 will go to N Street.
  - Motion by Hammer to have someone from GPTN write a letter to the editor from the board in support of N Street. Seconded by Arp. Approved. Hirsch volunteered to write the letter.
- Bentrup reviewed Bike to Work Week May 11<sup>th</sup> through the 15<sup>th</sup>.
  - Motion to support Bike to Work Week with a \$500 donation to City of Lincoln for supplies by Bentrup. Seconded by Thacker. Approved.
  - M. Torell reviewed that on May 6<sup>th</sup> at 2:30 PM there will be a ride at the Capital and the Governor will be presented a Nebraska Bicycling Alliance, Proclamations for Bike to Work Week and Bike to School Day.
- Bentrup reviewed Streets Alive in the Clinton neighborhood at Peter Pan Park.
  - Motion by Bentrup and seconded by Wehrbein to support the Streets Alive with a \$500 sponsorship. Approved.

## Public Relations Committee

- Hirsch mentioned they haven't met yet. Plan on doing so soon.
  - Three events coming up.
    - Hartley School and Hirsch will attend.
    - Peter Pan Community Event on May 8<sup>th</sup>. Smoothies at the event per Bentrup.
    - Red Dirt Running Company event. Noe to review that at the next meeting.

## **Government Relations Committee**

• Mary Torell mentioned they haven't met yet, but plan on tonight after the meeting.

## Trail Use and Activities Committee

- Report by Vannier. Next board meeting will be a party for Thacker at the Torell's.
- Tour de Lincoln Rides posters circulated. Rides reviewed. First three events are on Thursdays at 6 PM. The last ride will be on a Saturday. Volunteers needed to help with treats and ride leaders.
  - Motion by Vannier to have GPTN reimburse the cost of the refreshments (treats) for Tour de Lincoln. Seconded by Griffin. Approved.
- Hirsch reviewed that the Jamaica North Dedication is on May 8<sup>th</sup> from 5 to 6 PM.
- Messerer reviewed the updates on the Lincoln Bike Share and stated a CMAC fund has been approved for the Bike Share program for Lincoln. Still another 750k that needs raised for the project. Goal is to roll out the project in Spring 2016. There will be 15 stations in Lincoln. Hopefully one at the JSTC.

## **Finance Committee**

- Godfrey reviewed the highlights from the committee meeting including:
  - Keep the "may have an annual audit" language
  - Finance Committee will review the GPTN finances for inconsistencies and research any issues on a regular basis in lieu of a formal audit.
  - $\circ$   $\;$  No threshold for the Treasurer for check writing.
- Hirsch asked about Great Western Bank and Cornhusker Bank. Warren clarified. GWB will have the account closed soon and all future GPTN funds to go to Cornhusker Bank.

- Hirsch reviewed info including:
