Public Relations (Rachelle): No report. Dale reported on the newsletter. Working on the next newsletter (Summer issue). Give2Lincoln postcard went out to our mailing list.

Trail Use and Activities Committee (Mary): Had a committee meeting last week and discussed trail advocacy—bike safety, trail clean up, etc. Chris Sonderup at Cycleworks has offered to donate 2 vouchers each week at Tour de Lincoln to use for helmets. Signage for the trails was discussed which has to be approved by Parks & Rec. PSAs potentially happening on all four radio stations at the Broadcast House for Tour de Lincoln.

Trail Trek/Lincoln Trail-A-Thon (Dena/Ashley): LTA had the first two all trails completed.

Trail Trek is coming together and have 40 more registrations compared to this time last year. There are a few more new sponsors as well—we're at \$14,500.
